Name of client(s): **Bride and groom as per above** (hereinafter known as "Contracting Party")

1. This agreement constitutes an order for wedding photography services, including the taking of wedding pictures as agreed to by both parties: **Noah Fallis** hereinafter known as "**the Photographer**", and Contracting Party. The Contracting Party agrees that the Photographer may use the images of the Contracting Party for public advertising on internet, print, or broadcast tv for the purpose of promoting the Photographer's company. Photography sent to the Contracting Party in any form, electronic or printed, cannot be resold or used for any commercial purpose without written consent of the Photographer.
2. Although all care will be taken with digital images taken at the wedding, the Photographer limits any liability for loss, damage, file corruption, accidental eraser, nuclear bomb, sharks with lasers, or failure to deliver images for any reason to the return of deposits made.
3. It is understood and agreed that no other professional photographer (e.g. another paid wedding photographer) will be allowed to photograph or take pictures at the wedding while the Photographer is working, and that any breach of this agreement shall constitute a reason for non-completion of the job with no liability to the Photographer and shall result in the loss of any deposit made by Contracting Party.
4. On signing of this agreement by both parties hereto, the Photographer will reserve the date and times agreed upon and will not make another reservation for the specific date and time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.
5. The final photography fee, plus GST is to be paid in full within 7 days after the wedding day. Photography will not be release until payment is received in full. **Cheques payable to Noah Fallis Photography.**
6. Time exceeding chosen package time will be billed at \$250/hr with prior notice given. Shipment of data DVD's will be withheld until payment for all services, inclusive of overtime (if applicable) is made in full.
7. Any reposting of web images to websites other than [calgaryweddingphotographer.com](http://calgaryweddingphotographer.com) (eg. Facebook) must have a photo credit of "photos by: CalgaryWeddingPhotographer.com". Any links posted on other sites that point to [calgaryweddingphotographer.com](http://calgaryweddingphotographer.com) web galleries must link the words "Calgary Wedding Photographer" to the specific link provided by the photographer. For those of you who aren't into web publishing or blogging, don't worry about that last sentence.
8. Contracting Party hereby releases, discharges and agrees to save harmless the Photographer, its heirs, legal representatives, assigns, employees or any persons or corporations acting under permission or authority from the Photographer from and against any liability as a result of any distortion, blurring, optical illusion, compositing, or any digital alteration, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the photographs.
